The revenues that allow American Friends to make grants comes from individuals, businesses and philanthropies that wish to underwrite the preservation of Canada's natural heritage and build the capacity of Canadian entities engaged in natural resource preservation. Donors to American Friends may recommend that the directors consider making a grant to a specific Grantee or area of Canada. Through American Friends' General Support Program the organization was able to assist 8 Canadian land trusts in achieving their conservation objectives.

Ingersoll Island is located along the eastern shore of Georgian Bay in Lake Huron, adjacent to the Georgian Bay Land Trust's Sandy Island Reserve. The Reserve protects 425 acres of regionally rare community types, such as red oak-beech forest, which are also recognized as significant at a national and/or global scale. In addition, the intact, undisturbed nature of the majority of both Sandy Island and Ingersoll Island provide for high quality habitat for many rare plant and animal species, including the eastern massauga rattlesnake, listed as threatened in Canada and globally rare. American Friends received fee title to 47 acres.

This 1,285-acre property is part of Delta Marsh, a large freshwater wetland whose importance has been internationally recognized through Ramsar designation. The Marsh is 46,460 acres in size and is separated from Lake Manitoba by a beach ridge. Delta Marsh is a Manitoba Heritage Marsh and has been designated as an Important Bird Area due to its importance for waterfowl and neotropical migrants. The property is bordered on three sides by lands owned by the Canadian government. Ducks Unlimited Canada is in the process of purchasing 133 acres of an adjacent quarter section to expand protection of Delta Marsh. A U.S. partnership that operated the property as a hunting lodge donated fee title to American Friends.
